

#### 4. Evidence and Documentation

Professor Hoegh-Guldberg and Mr. John Cook have repeatedly and falsely claimed that carbon dioxide from human activity causes damaging global warming and damaging global climate variability including global climate change. That is their core claim. Empirical evidence proves their claims false.
