

Dear Mr. Baldwin:

Re: Your letter number MC15-010646; Senator Birmingham's letter MC14-19718

Thank you for your letter dated 1st June 2015 in reply to my letter and report dated 27 February 2015 to you and Senator the Hon Simon Birmingham.

Your reply does not address the core points of my letter and report of 27 February. These are as follows:

Firstly, please refer to my report's pages 19-23 and please (1.0) answer my letter's core question near the bottom of page 1. Please specify (1.1): are you aware of the implementation across Australia of the UN's 1992 Rio Declaration for twenty-first century governance since Paul Keating's government signed it in 1992? If you were not previously aware, please advise (1.2) whether or not you support the Declaration's implementation. If you were aware of its implementation, please advise (1.3) whether and for what reason you support its implementation given that it has never been approved by the Australian parliament and never been informed to the people of Australia who have had no opportunity to discuss this severe and unlawful infringement of our sovereignty, governance, livelihoods and freedoms.

Please advise (1.4) whether you are currently still a British citizen.

Secondly, please address the brazenly false statement in the penultimate paragraph of Senator Birmingham's letter to me dated 18 December 2014 and received by email on 24 December 2014. It seems likely that Senator Birmingham's falsity appears to be due to his being misled by the Bureau of Meteorology and for which I hold BOM responsible. From Senator Birmingham's email of 20 March 2015 (copy enclosed) it seems he is not interested in restoring his integrity and relies upon you to do so. Please advise (2.0) what action you have taken and will take to correct the penultimate paragraph of Senator Birmingham's letter, based presumably on the advice from what is now your office and/or from BOM. I hope that you agree that this fundamental issue of probity is among your position's primary responsibilities.

Thirdly, my letter and report of 27 February 2015 makes you aware of the complete lack of empirical scientific evidence within BOM and CSIRO for their unfounded claim that CO₂ from human activity causes harmful global warming and climate variability. That is a clear and unequivocal conclusion from federal Freedom of Information requests on BOM and on CSIRO's Chief Executive covering the period 2005-2013, from replies sent by BOM's Director and CSIRO's Chief Executive and Group Executive-Environment in response to my requests for empirical scientific

evidence as proof of **human causation**, and from detailed investigation of CSIRO and BOM reports by myself and other independent engineers and by recognised climate scientists.

Mr. Baldwin, the third paragraph of your letter dated 1st June 2015 is nonsense. None of the bodies you name has ever provided any empirical scientific evidence that CO₂ from human activity causes harmful global warming or harmful global climate variability. If you disagree, please provide (3.0) the specific location of specific evidence upon which you rely. That is, please provide report or book title and date, authors' names, reporting organisation and specific chapter and page numbers. If you do not provide such specific location of human causation in the form of empirical scientific evidence it will verify that you have no such evidence.

This is fundamental to honest and competent governance and policy and as you are a former management consultant I assume you are aware that sound policy and advice must be based on **empirical evidence of causation**. To do otherwise would be grossly negligent or dishonest and, given the facts you have received, it would willfully contradict the interests of Australia and of Australians.

Your fourth paragraph is merely an appeal to authority and not empirical evidence. It is unsubstantiated opinion.

Your letter then embarks in subsequent paragraphs into a justification of Liberal party policy that removed the ALP-Greens carbon dioxide tax (and for that voters are grateful) and that burdens Australians with Greg Hunt's Direct Action policy that is stealthily putting a price on carbon dioxide.

Your letter states that your government is committed to reducing Australia's (carbon dioxide) "emissions" yet has no empirical scientific evidence justifying the need for destroying Australian industry and jobs by imposing additional costs on energy. My reports pages 24-26 detail some of those costs imposed on Australians by Direct Action and by the Renewable Energy Target introduced by your Liberal-Nationals government under John Howard. These are highly regressive taxes on the poor and are contributing to the destruction of Australian industries particularly manufacturing, mining and agriculture, and are killing jobs and needlessly hurting our economy.

I hope that you will demonstrate interest in these matters of Australian sovereignty and governance, integrity and the making of sound policy and that these are important to you. I look forward to your timely response and remain available to meet with you to discuss these issues and to provide further explanation or context for you.


